

This is a combined synopsis/solicitation for commercial items prepared in accordance with the format in Subpart 12.6, as supplemented with additional information included in this notice. This solicitation, F1C0CR2207A001, is being issued as a Request for Quotation (RFQ). This procurement is a 100% Small Business set-aside IAW FAR 19.502-2 (a). The NAICS code is 314110 and the small business size standard is 500 employees.
